Set Parental Control on IPAD

How to set parental controls on an iPad

- 1. Launch the Settings app.
- 2. Tap the "Screen Time" tab.
- **3.** Tap to set a Screen Time passcode, and enter your chosen numeric code (if this is already done, the tab will read "Change Screen Time Passcode," which you may want to do periodically).
- 4. Tap "Content & Privacy Restrictions."
- **5.** Enter your passcode.

Now you will need to spend some time customizing the allowances and restrictions as you see fit. You should tap "Content Restrictions" and set the ratings you will allow for media (G-rated movies, e.g.), filter web content (no explicit language, for example), and set limits to the types of websites your child can visit.





Do you know:

- A New Tax System (Family Assistance) Act 1999 (the Family Assistance Act), states there are circumstances prescribed in the Child Care Subsidy Minister's Rules 2017 (Minister's Rules) when an individual will not be eligible for Child Care Subsidy for a session of care where the care is provided by a Family Day Care educator (or their partner) to a child that is related to the educator or their partner.
- The majority of children in the care of a Family Day Care educator must be children not related to the educator/partner.
- To be eligible for CCS the immunisation requirements continue to apply.
- in order for parents to be eligible for CCS, they must have a liability to pay for the session of care, established under a Complying Written Arrangement, that amongst other things, sets out the terms and fees for care
- providers must issue parents with a fortnightly statement, which includes various details relating to the sessions of care, the fees and CCS and ACCS entitlements
- Parents must confirm details about the child's enrolment, submitted in the enrolment notice by a provider, before CCS payments can be made – parents can also review and query any subsequent


